



Certification is recognised and rewarded by national and international organisations:







Google

Eligibility: ECO certified hotels

Benefits: Google is introducing a way for certified hotel owners to highlight their sustainability practices to environmentally-conscious consumers. ECO Certification is one of only 29 certification programs worldwide that was approved by Google. You can add your ECO Certification to your Google business listing - click here for more info.

Booking.com

Eligibility: ECO certified accommodation providers (incl. caravan parks, B&Bs etc)

Benefits: According to Booking.com research, 73% of travellers say they would be more likely to book a property with sustainability practices in place. ECO certified accommodations listed on Booking.com now display the Sustainable Travel Badge - an easy way for travellers to identify sustainable properties. Click here for more.

EA & QTIC Partnership

Eligibility: ECO, ROC or Climate Action certified operators based in Queensland

Benefits: Under this agreement, the cross recognition between programs means that you are eligible to redeem accreditation through the Quality Tourism Accredited Business (QTAB) program through QTIC at no additional cost, and take advantage of the program's valuable benefits including free ReviewPro access, automatic eligibility for nomination in the QLD Tourism Awards, and many more. Government recognition

Certification is recognised and rewarded by Australian state licence and permit managers:

state	certification	benefits
QLD	ECO	 GBRMPA offers 20 year permits to operators on the Reef certified at the Ecotourism or Advanced Ecotourism levels and recognise and promote them as High Standard Tourism Operators. Certification is required for operators in Queensland who hold a 15-year Commercial Activity Agreement for guided tours in: K'Gari - Fraser Island Recreation Area. Great Sandy Marine Park (whale watching). Springbrook National Park (glow worm tours).
WA	ECO	 DBCA recognise ECO Certification through: Access to 1, 3 or 5 year licences for Nature Tourism operators. Access to 7 year licences for Ecotourism operators. Access to 10 year licences for Advanced Ecotourism operators. Tour operators offering "swim with" experiences must be Ecotourism or Advanced Ecotourism certified.
NSW	ECO	 Certified operators are eligible for a 10% discount on their annual licence fee.
NT	ECO & ROC	 Certification is mandatory for Parks Australia parks (Kakadu National Park and Uluru-Kata Tjuta National Park). ECO and ROC certified operators in Uluru and Kakadu can apply for a 3-year standard land based permit (in addition to 1 year permit).
SA	ECO, CA & ROC	 Access to a 3 year Commercial Tour Operator Licence for Nature Tourism and Climate Action operators through National Parks South Australia Access to a 5 year Commercial Tour Operator Licence for Ecotourism, Advanced Ecotourism and ROC operators through National Parks South Australia
TAS	ECO	 Products operating in Tasmanian National Parks are required to hold accreditation. ECO Certification is one of the recognised programs.
VIC	ECO & ROC	 Access to 3 year licences for Nature Tourism and ROC operators through Parks Victoria. Access to 10 year licences for Ecotourism and Advanced Ecotourism operators through Parks Victoria.
